Dear Madam

**Unlawful Content**

We write further to your email of 19:04, 18th November 2007.

We have made it extremely clear that the publication of the "*Northern Rock Executive Summary*" ("the Work") on your client's website constitutes an unauthorised copyright infringement.

Despite the aforementioned notification, which was made pursuant to 17 U.S.C. Section 512 and the Digital Millennium Copyright Act five days ago, we note your client is continuing to publish the Work. All necessary information has been supplied in order for your client to comply with our request that the publication of the Work be immediately suspended. There is no justification for your client's continued publication of the Work. We reserve all of our client's rights in this regard including in relation to the flagrant infringement of copyright.

Please urgently now ensure that the Work is removed from your client's website immediately.

Furthermore, publication of the Work is contrary to an Order of the Royal Courts of Justice dated 22 November 2007 which prohibits publication, disclosure or communication of the Work. This Order extends the original injunction granted on 13 November 2007 until trial or further Order.
